Dear Vendor,

Thank you for your interest on our Rodeo Days Event that will take place in downtown Preston. Please read this information carefully and fill out the required information completely so that we can facilitate your needs when you arrive in town. It is our desire to have a successful event and we require your help to make it so.

All booth assignments will be made after your check has cleared the bank on a first come first serve basis. There will be NO REFUNDS due to inclement weather or other occurrences beyond our control. We reserve the right to make booth assignments.

Vendors are responsible for removal of all debris (including cardboard boxes) from the sidewalk area and need to keep their booths clean of debris. All vendors shall conduct business only in area provided. Vendors cannot display, offer for sale or attempt to sell junk or rummage items.

**ABSOLUTELY NO DRUG PARAPHERNALIA, NO OFFENSIVE MATERIAL OR ANY ITEMS DEEMED INAPPROPRIATE BY THE RODEO DAYS COMMITTEE WILL BE SOLD. YOU WILL BE GIVEN ONE WARNING AND IF IT IS NOT ADHERED TO YOU WILL LOSE YOUR SPACE WITH NO REFUND.**

The following rules and regulations are for rental of space at the Preston Rodeo Days Sidewalk Sale on State Street in Preston, ID. Rodeo Days will be held each day from 10:00 am to 5:00 pm (All vendors need to stay these hours and are welcome to open earlier or stay later that the hours listed.)

Booth sizes are approximately 8' X 10'. If more room is needed please note it on the application. A four-foot-wide pathway for each booth between the curb and the building is required. We reserve the right to limit the number of similar booths. Any large should be positioned so that it does not block doors and windows of the merchants. No booth assignment will be made without a full space fee and COMPLETED application.

**Set-up time is 6:00 am until 10:00 am.** Participants must provide their own displays, tables, etc. Awnings for shade are encouraged, as there will be no shade or trees. Alcoholic beverages are prohibited. Pets are discouraged and must remain inside your assigned space and leashed.

Parking for vendors is available at the church parking lot (no overnight parking) and in the County parking lot behind the stores on the west side of State Street. No parking is permitted on State Street at any time; any vehicle in violation will be towed. Vendors will be able to load and unload in front of their booth for a limited time.

Please note that vendors will be required to cooperate with local businesses and government agencies.

Food vendors are REQUIRED to purchase a Food License.  
PLEASE CALL (208) 852-0478. There is a \$65.00 fee which allows you to participate in three events in the Southeast Idaho District.

**Costs per Booth:**

For all three days - \$75

Minimum (for less than the three days) - \$50

**There will be no electricity provided, so plan to bring you own generator (a quiet one) if one is needed.**

## HOLD HARMLESS AGREEMENT

No refunds for cancelation will be honored after June 30 for any reason. Vendor agrees to hold the Rodeo Committee, its individual members, and/or Preston City harmless from and against any and all liability, claims, or damages arising from use of space or spaces.

The *VENDOR* understands and acknowledges that the Famous Preston Night Rodeo normally requires all vendors who agree to be a part of the sidewalk sale of *THAT FAMOUS PRESTON NIGHT RODEO* to secure a certain insurance coverage, evidenced by a Certificate of Insurance.

The *VENDOR* certifies that after diligent effort, the *VENDOR* has been unable to secure insurance coverage at a reasonable cost.

Therefore, the *VENDOR*, for himself, his heirs, representatives, successors and assigns, in consideration of the permission to participate in a "Preston Night Rodeo Sidewalk Sale", and in consideration of *THAT FAMOUS PRESTON NIGHT RODEO'S* agreement not to require the *VENDOR* to secure the insurance coverage customarily required of vendors, covenants with *THAT FAMOUS PRESTON NIGHT RODEO* and its successors, representatives, and assigns, as follows:

1. The *VENDOR* covenants to save, defend, keep harmless and indemnify *THAT FAMOUS PRESTON NIGHT RODEO*, and all of its agents and employees (collectively), from and against any and all claims, loss, damage, injury, cost (including court cost and attorney's fees), charge, liability or exposure, however caused, resulting from, arising out of, or in any way connected with the *VENDOR'S* participation in a "Preston Night Rodeo Sidewalk Sale" within city limits.
  - a. The terms of this Hold Harmless Agreement shall continue in full force and effect until such time as *THAT FAMOUS PRESTON NIGHT RODEO* determines that the covenants described in paragraph 1, above, shall no longer be necessary.
  - b. In executing this Exhibit, the *VENDOR* represents and warrants that the *VENDOR* has completely read, fully understood, and voluntarily accepted its terms and has executed it expressly to make the covenants in favor of *THAT FAMOUS PRESTON NIGHT RODEO* described in paragraph 1, above.
